

## Please submit this form at least one month in advance of the Sacrament.

I recognize this is a great honor with lifetime responsibilities. I also understand it to mean that the young person and his/her parents recognize me as someone who is an active and regular participant in the practice of the Catholic faith.

## There are 5 steps to complete the request for a Sponsor Letter for Baptism or Confirmation at another Church.

- 1. Insert the name of the Pastor and Church, the address of the Church where you have been asked to be a Sponsor and the name of the child in the appropriate spaces.
- **2.** Attach the following documents:
  - a. Proof of age noting that the Sponsor is at least 16 years old [state or government identification];
  - b. Baptismal Certificate;
  - c. First Holy Communion Certificate;
  - d. Confirmation Certificate.
- 3. Submit this completed letter and the above documents to our office at least one month in advance of the Sacrament via mail to Saint Teresa of Avila, 306 Morris Avenue, Summit NJ 07901, by dropping into the mail slot of the parish office front door or via email to office@stteresaavila.org.
- 4. The Pastor will sign the letter and stamp with the parish seal. Please review the letter in advance with the requesting parish as we will not provide any other certification. Please allow 14 days from our receipt of the letter and all four (4) documents to receive the signed letter.
- **5.** We will contact you after the letter has been signed to make arrangements for you to receive the letter.
